We do not collect information about our visitors from other sources, such as public records or bodies, or private organizations.

Children's Privacy

We do not knowingly collect personal data from children and take specific steps to protect the privacy of children by making reasonable efforts to ensure that a parent has authorized the collection of the child's personal data.

Confidentiality / Security

We do not give visitors to our Web Site the option of using a secure transmission method to send us their personal at this point in time. However we have implemented security policies, rules and technical measures to protect the personal data that we have under our control from, *unauthorized access, improper use or disclosure, unauthorized modification, and unlawful destruction or accidental loss.*
